300. Use of Force
300.10 – minor update to include “annual” reporting to the National Use of Force Data Collection per OAA standards.
308. Control Devices and Tech
308.09 Ensuring that policy is clear that training should occur every two years. Training and/or certification
313. Firearms
313.8 clarify the instructor shall be a ‘certified firearms instructor’ per OAA
315. Vehicle Pursuits
Skipping this tonight – Internal command has not had a chance for the further review before bringing to the table
323. Temporary Custody

323.1.1 Senate bill 1560 which took effect Jan 1, 2023, requires the term “alien” be replaced with “noncitizen”.

402. Bias-Based Policing

During our accreditation assessment, we discovered this policy lacked information on reporting to the state. This update meets OAA standard.

402.8 “Annual” training added per OAA standard

510. CURRENT Vehicle Towing/Vehicle Towing

Chose not to accept the Lexipol recommendations until counsel reviewed it and it was discussed with the policy workgroup and also internally

804. Property and Evidence

903. Prison Rape Elimination

Called PREA. Prison Rape Elimination Act

Federal law requires this policy as well as our accreditation through OAA.

Although we do not have a prison we are considered holding prisoners such as in our vehicles when transporting

Deleted sections identifying specific policy numbers, deleted Class C uniform and change made to the nameplate requirement

1055.4.3 – This agency content section (Medical Examinations) was deleted due to it being covered in 1055.6.
